In submitting my deposit and this form to Siberian Meow Cattery, I agree to the following:

\_\_\_\_ I understand that my deposit is non-refundable. I understand that this policy is in place to ensure that the buyer is committed to their kitten.

\_\_\_\_ I understand that In the event that Siberian Meow cannot produce the Siberian Kitten specified in this Agreement, a full refund will be provided to Purchaser, or deposits paid by Purchaser will be applied toward another kitten, at the discretion of Purchaser.

\_\_\_\_ I understand that if I am picking up my kitten in person, I will pay the balance due with cash—no exceptions.

\_\_\_\_ I understand that if I am having the kitten shipped, the kitten must be paid for in full, this deposit form along with a completed and signed Siberian Meow Kitten Contract must be returned to Siberian Meow Cattery before shipping.

\_\_\_\_ I understand that as the buyer, I am responsible for all shipping costs as well as the cost of providing an adequate crate if applicable.

\_\_\_\_ I understand that the kitten available to me is at the discretion of the breeder. A similar kitten may be substituted if the original kitten becomes

unavailable.

\_\_\_\_\_I understand that this kitten is being sold with/without breeder rights (indicate one).

\_\_\_\_\_I understand that Siberian Meow cares deeply about welfare of our kittens. Thus, Siberian Meow Cattery reserves the right to terminate this Agreement at any time, if we feel Purchaser's home may not be suitable for the selected kitten. Siberian Meow will refund the deposit in full if this occurs.

\_\_\_\_\_I understand that this deposit agreement is legally binding to all parties involved. It applies only to the parties in this transaction, and is not transferable to any other person.
