Health Guarantee: Siberian Meow Cattery has a health guarantee that is valid for 12 months from day of transfer. Once you have taken possession of the kitten you will need to take him/her to your own vet for a checkup within 24 hours for the one year health guarantee to be valid. The Buyer will receive a health record from the Breeder's veterinarian as proof of examination, all vaccines received, as well as a schedule of the vaccines still needed to maintain the kitten's health in the future. Seller/Breeder warrants the kitten/cat is of sound health upon purchase.

The kitten will be de-wormed, inoculated and vet-checked. Breeder will refund the purchase price and accept the kitten/cat back if:

A: within the two week period, the kitten/cat is found to be medically deficient with an un-treatable or life-threatening problem. A veterinarian must certify in writing that the kitten/cat is ill or deformed in such a way as to make it unsuitable for the purposes of which it was purchased or an allergy family/individual tests negative for allergies via fur sample and/or visitation with the kitten/cat, but then develops allergies within 14 days of purchase.

Seller/breeder warrants that to the best of seller's knowledge, this kitten/cat is free of congenital defects; and this warranty covers a period of two years.

If the kitten/cat dies within the guarantee period despite medical treatment, compensation will be made only if a licensed veterinarian certifies the cause of death as congenital as described below. Should the kitten/cat die within that time as a direct result of congenital defect, the cat will be replaced only if an appropriate necropsy is performed or a veterinarian's certificate is provided as proof of cause of death. A replacement will be made of a kitten/cat of comparable quality and value, as available; or a monetary refund of purchase price less non-refundable deposit will be made by Breeder.

Immunizations: Seller does not immunize the Kitten for FIP or FeLV prior to sale, as these vaccines can depress the immune system of healthy cats. If Buyer immunizes the Kitten for FIP or FeLV, the Health Guarantees hereunder shall become null and void. Buyer bears sole responsibility for informing Buyer's veterinarian not to administer these vaccines.

Spay/Neuter: If kitten is intended to be a household pet then neutering or spaying is **REQUIRED**. Your kitten will be spayed/neutered before shipping/pick up. All expenses for the procedure are included in the kitten total sale price.

NO DECLAW CLAUSE: We have a "NO DECLAW" clause in our contract. If Buyer has the Kitten declawed the Health Guarantee hereunder shall be null and void. The kitten that you buy from Siberian Meow cannot be de-clawed, as de-clawing is a mutilation and considered detrimental to the health of the kitten. If the buyer does de-claw the kitten, Siberian Meow reserves the right to take the kitten back with no compensation to the owner. If there are Attorney's fees, the buyer that de-clawed the kitten shall be liable for all fees incurred. Seller will notify all known cattery network about such cruel fact, to make sure that nobody ever will sell another kitten to such an irresponsible owner.

The kittens have had their claws trimmed since babies and are used to the process before you bring them home. We also suggest trimming their nails as needed. By doing this the kitten will get used to it in no time! If you come to pick up your kitty, we will be more than happy to show you how to do it yourself. It is also a very inexpensive procedure to trim the claws.

It is highly suggested once the kitten(s) arrives at their forever homes they have a sturdy scratching post and/or cat tree to use, as they have been trained with one since they were a baby. It is cheaper to purchase a scratching post than replace your furniture and is less stressful.

Release of Liability: Seller is not liable for expenses incurred (including medical) due to or as a result of the above cat/kitten's actions. Seller does not guarantee eye color shade, coat color shade, coat length, size, weight, or personality of cat/kitten.

Proper Care: Buyer agrees to provide proper housing, diet, fresh water, parasite control, and general health care for the Kitten, including the completion of routine immunizations and boosters and prompt veterinary care for any illness or condition requiring medication or surgery. The Kitten is to be kept indoors only. The only time it is permissible for the cat to be outdoors is when under supervision on a harness and leash or when protected within an approved cat enclosure. The Kitten should be isolated from other pets for at least 72 hours to allow the Kitten to acclimate to its new surroundings. Any changes to the Kitten's diet should be made slowly, as sudden diet changes may result in episodes of diarrhea. Buyer agrees to feed a high quality, preferably, organic diet.

It is recommended that the Kitten have access to dry food and water at all times and be kept on a Kitten formula food until reaching the age of eight (8) months old. The Kitten has been litter-box trained using Feline Pine cat litter.

Transfer of Kitten: Buyer agrees that the Kitten will at no time be sold, leased, or transferred to any pet shop, animal dealer, animal research facility, animal shelter, nor anyone who has ever been convicted of neglect or cruelty to any human or animal. Buyer agrees not to abandon the Kitten. It is the intention of Seller that this be a permanent placement. If at any time Buyer becomes unable or unwilling to keep the Kitten, the buyer agrees to surrender the cat and all rights to the cat to the Breeder or her representative unconditionally without benefit of refund or any course of reclaim.

Liquidated Damages:

Seller's liability hereunder shall be limited to the purchase price of the Kitten, or as otherwise indicated by state law, which shall be Buyer's sole remedy in equity and law as liquidated damages hereunder.

Shipping Charges & Agreement: The cost of shipping is \$300 which includes airline ticket, transportation to airport, and airline approved carrier, and is separate from the sale price of the kitten. Buyer must pay Seller total shipping charges two (2) weeks prior to pending shipping date. Buyer agrees to e-mail or call Seller no later than twelve (12) hours after receipt of cat/kitten to confirm receipt. Buyer is responsible for any boarding fees as a result of airline delays. Seller is not responsible for parasites or contagious diseases that cat/kitten can contract while in transit. Buyer assumes all responsibility for the cat/kitten when it is delivered to the shipper/airline. Seller will purchase the maximum insurance provided by airline as a protection to Buyer's investment if available.

Shipping charges will be waived if buyer will pick up kitten form Siberian Meow Cattery or Cat Show identified by breeder.

Please feel free to contact us anytime with any questions or concerns about your kitty. We want to be sure our kittens are doing well in their new homes and would appreciate updates via email, snail mail, or phone. If you provide us with pictures of the kitten, we would be more than glad to publish them on our website, with your permission, of course.

Jurisdiction: It is agreed that this sale is taking place in the State of California, USA, and it is agreed that this contract will be interpreted pursuant to the laws of the State of California USA. Therefore, any legal issues are to be handled in the court system of Santa Clara County, California, USA. Buyer shall be liable to Seller for any costs incurred, including court costs and attorney fees, associated with Seller enforcing the terms of this contract.

In signing this document, Buyer acknowledges that he/she has read and understands the terms herein and that Buyer agrees to all of the terms and conditions of the above sale.
